Subject: Information

Dear Sir / Madam,

The Angolan Government approved the legislative Presidential Decree Nr. 10/13 of 22 November (see "Amendment nr. 1/14") the new "Customs Tariff of Import Duties and Export."

Similarly, the Government approved the Presidential Decree Nr. 62/14 of 12 March, the "Review of the Regulation on the Import Activities, Trade and Technical Assistance to Road Equipment, repealing the provisions of Presidential Decree Nr. 135/10 of 13 July.

Thus, CNC hereby reiterates the prohibition to issue **Loading Certificates** regarding the import procedures which do not meet the requirements under this provision.

About the import of prohibited goods

Article 53 of the new Customs Tariff (Amendment Nr. 1/14), prohibits the import of a set of goods namely:

- a) Vehicles with Right Hand Drive;
- b) Vehicles presenting altered wheel from right to left;

- c) Used engines;
- d) Used tires;
- e) Cut vehicles;
- f) Used batteries.

About the import of used road equipment

Under the provisions of Presidential Decree Nr. 62/14, prohibits the import of:

- a) Light motor vehicles which have a maximum of three years of use, counted from the date of manufacture;
- b) Heavy vehicles which have a maximum of five years of use, counted from the date of manufacture.

Exceptionally, it is allowed to import (used) motor vehicles that have more than three years of use (for light) and have over five years of use (for heavy), in the following situations:

- a) Vehicles with over 30 years of manufacture, imported for cultural purposes and collection;
- b) Vehicles which have been donated or acquired by inheritance;
- c) A vehicle owned for over a year, imported by Angolan citizens diplomats, students, immigrants, workers or representatives of public or private Angolan companies abroad, when at the end of the mission and return to the country;
- d) Vehicles imported by diplomatic missions, consular offices and representations of international organizations.

Condition for the import of used road equipment

For the import of road equipment (used) vehicles must meet the following conditions:

- a) Presentation of proof of vehicle ownership issued by the country of origin or, if it is not in the name of the presenter, proof of acquisition;



- b) Presentation of proof of all the previous records of ownership of the vehicle, issued by the competent authority of the country of origin, clearly indicating the date of registration;
- c) The vehicles documents must have identification plates containing the serial number and year of manufacture;
